

Tuition fee reduction based on academic achievement



Deadline to submit request: August 8, 2025

In which cases am I eligible to request?

- I submitted the request within the deadline
- I have paid the first instalment of the tuition fee (40 %)
- I can only request it in the fall semester
- The weighted average of the subjects I completed at the UPFP in the two active semesters of the academic year preceding the fall semester in concern is 4,01 or higher
- In the semesters that are the basis for the calculation or earlier I completed all the obligatory subjects of my recommended curriculum, completed minimum 26 credit points in both semesters and have not had credit transfer of an obligatory course in the given two semesters.
- I don't have any expired, unsettled debt towards the University
- I have not been involved in cheating in an examination

What are the rate bands of this reduction?

- 4,01 – 4,49 —→ 50%
- 4,50 – 4,74 —→ 60%
- 4,75 – 5,00 —→ 70%





Tuition fee reduction based on the credits taken

Deadline to submit request: August 8, 2025

In which cases am I eligible to request?

- I submitted the request within the deadline
- I have paid the first instalment of the tuition fee (40 %)
- I have at least two active and closed semesters at the UPFP within the same student's legal status by the time of submitting the request
- I plan to register 18 or less credits in the given semester. (In case you are not completely sure if you will register 18 or less credits, it is still better to submit the request and in case your credits will exceed 18, the request will simply be considered invalid. However, if you only decide after the subject registration, it would already be too late to submit the request.)
- Previously I used this type of reduction maximum once.
- I don't have any expired, unsettled debt towards the University
- I have not been involved in cheating in an examination

What are the rate bands of this reduction?

- 0-6 credits —→ 50%
- 7-12 credits —→ 30%
- 13-18 kredit —→ 10%
- more than 18 credits —→ 0%

IMPORTANT: If I register additional subjects during the semester, the rate of the reduction will change! If the total number of my registered credits exceeds 18, I will lose the reduction!



Tuition fee reduction based on social needs

Deadline to submit request: August 8, 2025

In which cases am I eligible to request?

- I submitted the request within the deadline
- I have paid the first instalment of the tuition fee (40 %)
- In the one year preceding the submitting of the request unexpected circumstances appeared in my living conditions that are worthy of special consideration
- My eligibility for the Stipendium Hungaricum/Hungarian Diaspora scholarship ceased at the end of the preceding semester
- I don't have any expired, unsettled debt towards the University
- I have not been involved in cheating in an examination

What are the rate bands of this reduction?

- Based on the proposal of the Educational Committee **between 0 – 70%**

Deadline to submit request: August 8, 2025

In which cases am I eligible to request?

- I submitted the request within the deadline, certified by all organizational units that are competent in the justification of the elements of the application
- I have paid the first instalment of the tuition fee (40 %) and I do not participate in the Stipendium Hungaricum or other scholarship program
- I have at least two closed active semesters at the Faculty within the same student status prior to submitting this request and the mathematical average of the corrected credit index values coming from my completions at the Faculty in these two semesters exceed 2,0
- I justifiably gain points in the following elements on the application form: Progress of studies based on the curriculum, Average based on Corrected Credit Index, Professional or scientific activity, Public/community/ enrolment support activities.
- I don't have any expired, unsettled debt towards the University
- I have not been involved in cheating in an examination

What are the rate bands of this reduction (based on the number of points gained)?

How to submit my request?

Preparations

- Paying the first instalment of the tuition fee
- Filling out the request, collecting the supporting documents

Submitting the request

- **Deadline of other tuition fee related requests: August 8, 2025**
- After the deadline maximum within 7 calendar days by paying late fee
- In the electronic way determined by RO
- Deadline for correction in case of incomplete requests (failing to correct the request will result in the rejection of the request)

Decision

Appeal

- Only in case of a breach of law or regulation of the University
- Within 15 days from receiving the resolution on the decision
- Secondary Educational Committee carries out the procedure
